COVID 19 VACCINE MANDATORY FOR CHILDREN FROM 6 MONTHS TO 5 YEARS OF AGE.

In Brazil, there is a mandatory vaccination schedule for children. The Ministry of Health believes that vaccination is the most important measure for preventing diseases. They also believe that vaccination not only protects those who receive it but also helps the population as a whole.

The Ministry of Health offers a large number of vaccines against various serious diseases free of charge. These vaccines have already been tested several times to be applied safely. However, even with so many studies and tests, these vaccines can have adverse reactions, including leading to death.

It should be noted that the first vaccines were discovered more than 200 years ago.

Currently, the vaccination included in the Ministry of Health's calendar for children is already mandatory under the Child and Adolescent Statute - ECA.

Failure to comply with the rule is punishable by a fine of three to 20 minimum wages or suing for negligence and mistreatment, and parents may lose custody of their children.

The big dilemma that Brazil is facing at the moment is whether or not the COVID-19 vaccine is mandatory in the vaccination calendar for children aged 6 months to 5 years of age.

Well, the COVID-19 vaccine was produced in record time, as the world was going through a Pandemic. There was not enough time for all safety tests and adverse reactions to the vaccine to be carried out.

Currently in Brazil, the mandatory COVID vaccine for children aged 6 months to 5 years is being discussed in the National Congress. The Ministry of Health declared that now in 2024, this vaccine will be incorporated into Brazil's vaccination calendar.

However, there is great concern among the population about this mandatory vaccination, as there are many cases in the world of children who have had various negative reactions to this vaccine, and have also died due to account of immunization against COVID-19.

Some children had common reactions after receiving a dose of the COVID-19 vaccine, such as Pain, swelling and redness at the application site, Headache, Fever, Tiredness, Diarrhea, and Body aches. However, there were more serious reactions, with a significant number of children presenting MYOCARDITIS (inflammation of the heart muscle).

What about these children who develop/developed illnesses due to the COVID-19 vaccine? Who will be held responsible? Who will pay for the treatment they will need?

What about children who died as a result of COVID vaccination? Who will be held responsible for these deaths?

The answer to these questions is NOBODY. Unfortunately, that's it. These situations are treated as fatalities.

Given all these situations, parents will have the security and peace of mind to submit their children to the COVID-19 vaccine. There is no safety in subjecting a child to this vaccine.

The medical community in Brazil says that the COVID-19 vaccine in children is safe. Here in Brazil, there were no serious adverse reactions, the reactions there were mild or moderate (headache, fever, myalgia, and other expected reactions). They also reported that there were no deaths with a causal relationship consistent with the vaccine used.

Given what happened in other countries and Brazil, we began to analyze the issue of mandatory COVID-19 vaccination for children aged 6 months to 5 years of age, from a legal perspective. And what we can see is that there is a collision between the fundamental rights to health and individual freedom.

The mandatory COVID vaccination goes against the individual freedom of each human being, and in the opposite sense, the refusal of this vaccine poses serious risks to the health of society as a whole, that is, there is a conflict of individual and collective interests.

The 1988 Federal Constitution ensures several fundamental principles, one of which is the protection of human dignity. Individual freedom is an unquestionable value in this context, and the compulsory imposition of vaccination on children could be interpreted as a disproportionate restriction on this right.

Health protection is a fundamental right of individuals guaranteed by the Federal Constitution of 1988, however, in theory, the State could not interfere in the individual freedom of its citizens, and freedom cannot be violated, based on the principle of intervention minimum.

The autonomy of will, guaranteed by legislation, gives individuals the right to decide about their own bodies, as well as the body of their dependents, especially in the area of health. Imposing compulsory vaccination on children can be interpreted as excessive State intrusion into the private sphere of families.



Each person takes care of their own body, being supported by the Federal Constitution of 1988, which provides for the right to inviolability of privacy and the principle of human dignity. In the case of children, this right is guaranteed by their parents.

We are faced with the conflict between individual and collective rights. On the one hand, we have the rights of each citizen and on the other, we have the rights of the collective. The way to resolve this conflict would be to consider (balance) between these two fundamental rights, and not simply impose on citizens that they must vaccinate their children from 6 months to 5 years of age against COVID.

Informed consent is an ethical and legal principle that recognizes the importance of informing individuals about the risks and benefits of medical interventions, allowing them to make informed and autonomous decisions.

In the context of vaccination, imposing mandatory vaccinations on children can be seen as a violation of this principle, especially when there is no clear scientific consensus on the specific risks and benefits for this age group.

The use of balancing is the method to be used when faced with a collision/conflict of fundamental rights.

When two fundamental rights are at stake where only one of them is applicable, there is an understanding that there will be no violation of one of them, but rather that both would have partial protection.

Furthermore, the right to health, although a fundamental right, cannot be interpreted in isolation. The balance between the protection of collective health and the preservation of individual rights must be considered. The State must promote health, but it must do so in a way that respects democratic principles and individual rights.

Therefore, forcing citizens to vaccinate their children against COVID-19 is arbitrary and violates a right guaranteed by the 1988 Federal Constitution.

On the other hand, there is the right to health for the entire community, which is also a fundamental right guaranteed by the 1988 Federal Constitution.

As stated above, the solution is balance. Citizens who do not wish to vaccinate their children against COVID-19 for fear of the reactions it has already caused to children in other countries do not have the right to expose the community to the danger of contracting this disease.

Given everything that has been said, what could be done is to impose safety measures on people who have not been vaccinated, such as prohibiting them from going to certain places without taking due care such as using a mask and using alcohol gel. However, the State could never force a citizen to vaccinate their children against COVID-19, as individual right must be preserved.

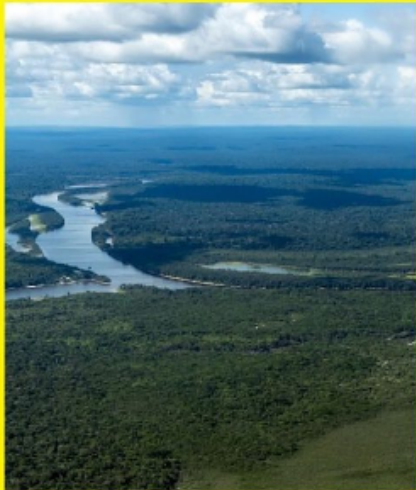

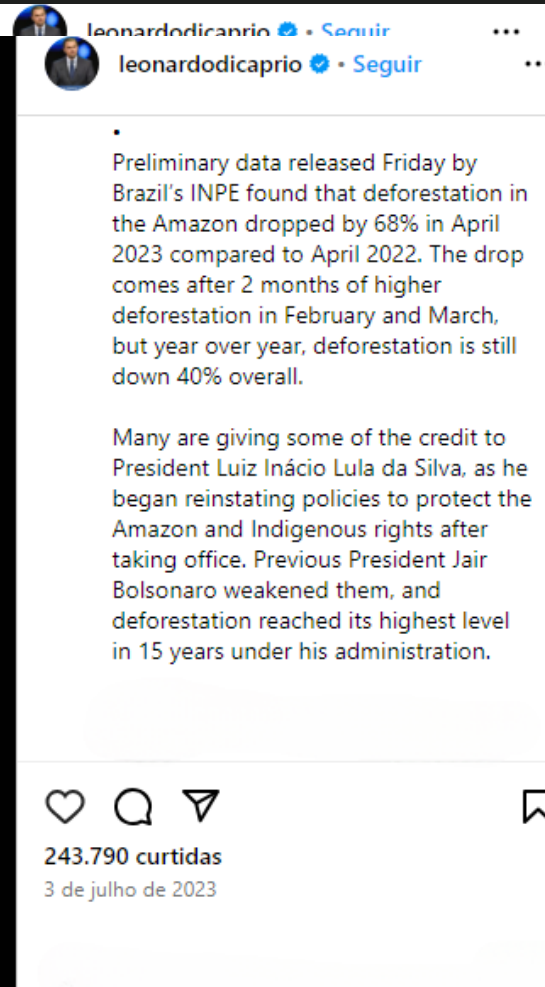
Leonardo DiCaprio is a dedicated environmental advocate and has been praised by several environmental groups and institutions for his work, including the UN, which named him its climate change representative in 2014. In August 2020, actor Leonardo DiCaprio commented critical of Jair Bolsonaro on his social networks. DiCaprio shared news published by the English vehicle The Guardian about deforestation in the Amazon.

“Preliminary data indicate an increase of 7% in August. Brazilian President Jair Bolsonaro is under international pressure to inhibit the fires, but has publicly doubted them in the past, blaming opponents and indigenous communities,” commented Di Caprio. “

In April 2023, Dicaprio praised the current president and spoke about data from INPE

Under Lula, deforestation of the Amazon in April 2023 was 68% lower than 2022

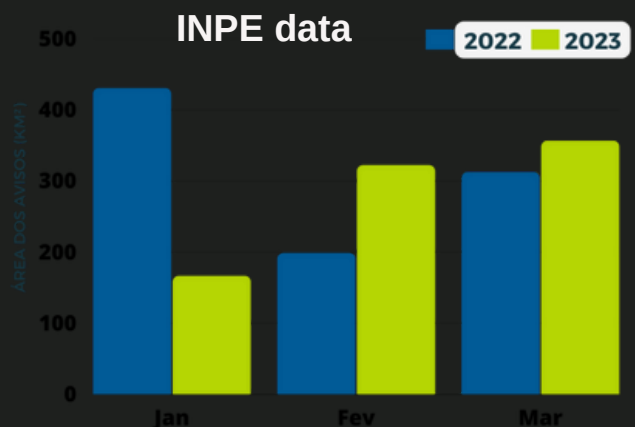
However, according to the website *amigosdaterra.org*, fires in the Amazon increased by 78% in March compared to the same period last year; deforestation showed a slight increase of 11% compared to the previous year

The first three months of 2023 were not easy for the Amazon. After breaking a record in February, deforestation and especially fires continue to rise in March. Data from the National Institute for Space Research (INPE) show that 356 km² were deforested in the month, an increase of 10% compared to February and an 11% increase compared to the same period last year.

Among the states in the region, Amazonas was the state with the largest deforested area (126.85 km²), followed by Pará (82.6 km²), Mato Grosso (79.6 km²), Rondônia (32.6 km²) and Roraima (29.5 km²).

Given these data, the month of April meant nothing, as the concentration of both fires and deforestation was at the beginning of the year. Deforestation increased by 11% compared to the previous government

Blaming the former government is just a matter of creating a narrative to mask the current situation.



RECORD IN OCTOBER 2023

With 22 thousand fires, the Amazon has the worst October in 15 years according to wwf.org, it broke a record for fires in 2023, under the Lula government an increase of 59% compared to October 2022. The states that had the greatest growth in fires in 2023 are Roraima, with an increase of 121% (2 thousand outbreaks), and Amapá, with a jump of 116% (1,913 outbreaks).

The numbers recorded in October 2023 in the biome exceed by 34% the historical average for the month since 1998 when Inpe began monitoring fires in the Amazon. Compared to October 2022, increases of 250% were recorded in Roraima (409 outbreaks), 157% in Amazonas (3,858 outbreaks), 74% in Amapá (1,063 outbreaks), 52% in Pará (11,378), and 49% in Acre (1,675).

Remembering is living, according to INPE, in the legal Amazon region, in Lula's first term, there were a total of (2003-2006) 938,017 active outbreaks detected by the satellite, in the second term (2007-2010) 714,921 active outbreaks, and the year by Jair Bolsonaro (2019-2022) 524,183 active outbreaks. There is a large reduction from one government to the next. The record was in 2004, Lula 1, with 275,645 active outbreaks.

With a record in October 2023, incredibly, Leonardo DiCaprio did not speak out about the fires during the Lula government. Amazon is not partisan, so whoever helps it shouldn't be either, and not alone, DiCaprio and Jeff Bezos donated more than R\$900 million to Amazon, this was reported on 07/04/2023 by Poder360, two months after the inquiry of NGOs, CPI, to be established (June 14, 2023) in the Senate. After 4 years of attempts, they managed to install this CPI with the collegiate's objective of investigating the activities of NGOs in the Amazon.

For the senator, Plínio Valério, non-governmental organizations in the Amazon region are "very articulated" in society and there is "equipment" of different sectors.

Bolsonaro and his former Minister of the Environment and now deputy Ricardo Salles (PL-SP) have always supported the NGO's CPI, he mentioned in his mandate as minister that there were irregularities in the contracts and that data was manipulated.

According to the Dário do Poder, the NGO CPI investigated transfers from 2001 to 2006. Only for NGOs called "associations" and "institutes" there were more than R\$5 billion. The total revenue calculated by the CPI from "non-profit" private entities, according to Siafi, was R\$13.7 billion.

"They have money to contest elections until 2038", stated the STF minister, highlighting that the party was hampered by Operation Lava Jato (Quote by Gilmar Mendes referring to the PT in the Lava Jato operation)

Is this why it is so difficult to open the CPI for NGOs? With so much money from NGOs, could this be another source of illegal income for the PT?



THE PAST CONDEMN YOU

Aldo Rebelo, FORMER MINISTER, OF Lula and Dilma in an interview for Brasil Parallel said "In Brazil, everyone is investigated and held accountable. Everyone. Companies are inspected by the Federal Revenue Service. If there is a complaint, it could break the confidentiality of companies. Individuals are investigated, but the Supreme Court decided to protect non-governmental organizations.

And what I ask is the following: Why did NGOs go to the Supreme Court to prevent the CPI from having access to the origin of their resources? What exactly did they have to hide?"

According to him, environmental NGOs transform the environment into a source of money collection.

He revealed that many are based in Europe, but open offices in São Paulo and begin to spread fear, selling a threat and asking for funding to help protect, for example, the Amazon



With all these facts, are the NGOs, INPE, and HOLLYWOOD, really interested in protecting the Amazon?

Because the more fires, the more resources need to come in to maintain the biome. An NGO that receives enormous amounts of money, and benefits its members, what interest does it have in ending it?

NGOs are private, non-profit entities, to add or even improve something in a given society.

In this understanding, NGOs should have a period of time to operate, not being able to be eternal, and they could not renew and operate in the same region.

It makes no sense to set up an NGO and not solve the problem, NGOs need to have a start and end date.



DEMOCRATIC MEASURES TO OPPOSITION PARLIAMENTARIS

Although the term DEMOCRACY means a political system in which sovereignty resides in the people, who exercise it directly or through representatives, a form of society that recognizes and respects the freedom and equality of all citizens before the law as essential values.

A country whose form of government is democratic, in theory, should defend equality rights in its practice, but what we have evidenced are facts that are opposite to the theoretical definition. Using the argument of democracy to restrict those who differ from the opposition's objectives, interests and thoughts has been a common practice of democracy defenders.

An example of this is Deputy Daniel Silveira, who had his arrest ordered based on indecent speeches addressed to a minister. Regarding speeches, profanity, pejorative and/or slanderous words, and lack of decorum, they tend to hurt the ego and cause negative results that can lead to lawsuits by the laws that comprise it for the defense and justification of those involved. However, the words were spoken by a parliamentarian, who, despite knowing the negative effect that could occur, resorted to using the prerogative provided for in the Brazilian constitution, which gave him the right to PAY, let's see:



Federal Constitution of 1988

We, representatives of the Brazilian people, gathered in the National Constituent Assembly to establish a Democratic State, designed to ensure the exercise of social and individual rights, freedom, security, well-being, development, equality, and justice as values supreme of a fraternal, pluralistic and unprejudiced society, founded on social harmony and committed, in the internal and international order, to the peaceful resolution of controversies, we promulgate, under the protection of God, the following CONSTITUTION OF THE FEDERATIVE REPUBLIC OF BRAZIL.

Art. 53. Deputies and Senators are inviolable, civilly and criminally, for any of their opinions, words, and votes. (Wording given by Constitutional Amendment n° 35, of 2001)



To date, Deputy Daniel Silveira is in prison, by order of the offended minister

Following the case of Deputies Carmelo Neto, Deltan Dallagnol, Alcides Fernandes, Silvana, and Marta Gonçalves, who had their mandates revoked, even though they were elected by society in the electoral process, with significant numbers of votes, as a result of supposedly democratic decisions and with Based on questionable and somewhat curious information, they lost their rights to exercise their mandate. The Regional Electoral Court of Ceará (TRE-CE) decided to maintain the revocation of the mandates of deputies Alcides Fernandes, Carmelo Neto, Dr. Silvana, and Marta Gonçalves, from the Liberal Party (PL), for fraud in the gender quota in the 2022 elections.

Deputy Deltan Dallagnol, Voted on June 6, 2023, by the Chamber of Deputies (Mensa Act No. 72 of June 6, 2023, following a unanimous decision by the Superior Electoral Court (TSE) that rejected the registration of his candidacy, understanding that the former prosecutor tried to circumvent the clean record law.[271], anticipating his dismissal from the Public Ministry, given Administrative Procedures that could result in him receiving a Disciplinary Administrative Process (PAD).



Another situation to observe is that of Senator Sérgio Moro, who has been facing difficult days, trying in every way to remain in office, to the point of omitting an important hearing from former Minister of Justice Flávio Dino. He had been an active participant in the famous LAVA JATO operation, which resulted in several arrests of those involved, plea bargains, financial returns to public coffers, and even the arrest of the current president, who was later released by a decision of the supreme court. cut.

Senator Sérgio Moro is today accused by the Liberal Party and the Brazilian Federation of Hope (PT/PCdoB/PV) of having caused an electoral imbalance in the elections for Senator in October last year, where he was elected with 1.9 million votes (33 .5% of valid votes)

In addition to the revocation of mandates, another practice of democracy established in Brazil by the current government and ordered by Ministers is the famous and routine searches and seizures carried out by the Federal Police, with targeted mandates, we list: Deputies Carlos Jody, Alexandre Ramagem, Ricardo Arruda, the Senator Marcos Do Val, in most cases, without having the right to due legal process, suffered searches and seizures in their homes, offices and even within parliament itself, they are also in opposition to the current government.

Parliamentarians in favor of the current government have the same prerogatives and constitutional rights in common but seem to receive different treatment. They do not suffer searches and seizures, social media restrictions, much less administrative penalties.

It can be remembered that deliberate attacks both in parliament and on private social networks, biased speeches and defamatory attacks, bizarre messages, encouraging hatred and prejudice, against the previous government did not receive any retaliation from the ministers of the supreme court. So it is concluded that democracy in its essence, of the current government, are not democratic acts but rather autocratic acts by parliamentarians opposing it. This is how the new “right to equality” is defined.

Carlos Jody was the subject of a search and seizure by the Federal Police, as a result of the 24th phase of Operation Lesa Pátria on January 18th.



Former president Jair Messias Bolsonaro was ineligible for 8 years, following a democratic decision by ministers. The indictment alleged that Bolsonaro committed abuse of political power and misused the media during his 2022 campaign by promoting fake news. This was the reason that made Bolsonaro ineligible for eight years.



Ramagem was the target of a Federal Police operation on January 25th. PF agents carried out a search and seizure warrant at the parliamentarian's office in Brasília.

JAVIER MILEI ALERT!

THE WEST IS IN DANGER SAYS MILEI AT THE WORLD ECONOMIC FORUM IN DAVOS



Every year, the world's economic and political elite gather at the World Economic Forum in Davos, Switzerland, to discuss various global issues and decide the direction of the world. Among so many important authorities in the world, one of them stood out and gave an exclusive class, free of charge, on economics, the speech by the President of Argentina, Javier Milei, technically explained the economy, its history, how it should be applied and that The capitalist model is a single model that generates evolution in countries. See in full.

Good afternoon. Thank you very much.

Today I am here to tell you that the Western world is in danger.

And it is in danger because those who should defend Western values have been co-opted by a worldview that leads inexorably to socialism and, consequently, poverty.

Unfortunately, in recent decades, the top leaders of the Western world have abandoned the freedom model for different versions of what we call collectivism.

Some were motivated by well-intentioned individuals willing to help others, and others were motivated by the desire to belong to a privileged caste.

We are here to say that collectivist experiments are never the solution to the problems that afflict the world's citizens.

On the contrary, they are the root cause. Believe me: no one is in a better position than us Argentines to witness these two points.

Thirty-five years after we adopted the freedom model in 1860, we became a leading world power. As we embraced collectivism over the last 100 years, we saw how our citizens began to become systematically impoverished, and we fell to number 140 globally.

But before having the discussion, it would first be important for us to look at the data that demonstrates why free market capitalism is not only the only possible system for ending global poverty, but it is also the only morally desirable system for achieving this.

If we look at the history of economic progress, we can see how between the year zero and the year 1800 approximately, world GDP per capita practically remained constant throughout the reference period.

If you look at a graph of the evolution of economic growth throughout human history, you will see a graph shaped like a hockey stick, an exponential function that remained constant for 90% of the time and that skyrocketed exponentially starting in the 19th century.

The only exception to this story of stagnation was at the end of the 15th century, with the discovery of the American continent, but for this exception, throughout the entire period between the year zero and the year 1800, global GDP per capita stagnated.

Now, it's not just that capitalism has brought an explosion of wealth from the moment it was adopted as an economic system, but also, if you look at the data, what you'll see is that growth continues to accelerate throughout the entire period.

Throughout the entire period between the year zero and the year 1800, the growth rate of GDP per capita remains stable at about 0.02% per year.

So, almost no growth.

From the 19th century onwards, with the Industrial Revolution, the annual compound growth rate was 0.66%.

At that rate, it would take about 107 years to double GDP per capita.

Now, if you look at the period between the year 1900 and the year 1950, the growth rate accelerated to 1.66% per year.

So, you would not need more than 107 years to double GDP per capita - but rather 66.

And if you consider the period between 1950 and the year 2000, you will see that the growth rate was 2.1%, which would mean that in just 33 years we could double the world's GDP per capita.

This trend, far from stopping, is still very much alive today.

If we consider the period between the years 2000 and 2023, the growth rate has accelerated again to 3% per year, which means that we could double global GDP per capita in just 23 years.

That said, when you look at GDP per capita from the year 1800 to today, what you will see is that after the Industrial Revolution, global GDP per capita multiplied more than 15 times, which represented a boom in growth that lifted 90% of the world's population out of extreme poverty.

We must remember that, until the year 1800, around 95% of the world's population lived in extreme poverty. And this percentage fell to 5% by 2020, before the pandemic. The conclusion is obvious.

Far from being the cause of our problems, free market capitalism as an economic system is the only instrument we have to end hunger, poverty, and extreme poverty on our planet. The empirical evidence is unquestionable.

Therefore, since there is no doubt that free enterprise capitalism is superior in productive terms, the leftist doctrine attacked capitalism, alleging moral issues, saying - this is what the detractors claim - that it is unfair.

They say that capitalism is evil because it is individualistic and that collectivism is good because it is altruistic. Of course, with other people's money.

So, they advocate social justice. But this concept, which in the developed world has recently become popular, in my country has been a constant in political discourse for more than 80 years.

The problem is that social justice is not fair, and does not contribute to general well-being. Quite the contrary, it is an intrinsically unfair idea because it is violent.

It is unfair because the state is financed through taxes and taxes are collected coercively.

Or can any of us say we pay taxes voluntarily?

This means that the state is financed through coercion and that the greater the tax burden, the greater the coercion and the less freedom.

Those who promote social justice start from the idea that the economy is a cake that can be shared differently. But this cake is not a given. It is wealth that is generated in what Israel Kirzner, for example, calls the market discovery process.

If the goods or services offered by a business are not desired, the business will fail unless it adapts to what the market is demanding.

They will be successful and produce more if they make a good quality product at an attractive price. So the market is a process of discovery in which capitalists will find the right path as they go along.

But if the state punishes capitalists when they succeed and interfere in the discovery process, they will destroy their incentives, and the consequence is that they will produce less.

The pie will be smaller, and this will harm society as a whole.

Collectivism, by inhibiting these discovery processes and making it difficult to appropriate discoveries, ends up tying the hands of entrepreneurs and preventing them from offering better goods and services at a better price.

So how can academia, international organizations, economic theorists, and politicians demonize an economic system that has not only lifted 90% of the world's population out of extreme poverty but has continued to do so faster and faster?

Thanks to free trade capitalism, the world is experiencing its best moment. Never in the history of humanity has there been a period of greater prosperity than today? This is true for everyone.

Today's world has more freedom, is rich, more peaceful, and prosperous. This is particularly true for countries that have more economic freedom and respect individuals' property rights.

Countries that have more freedom are 12 times richer than those that are repressed. The lowest percentile in free countries is better off than 90% of the population in repressed countries.

Poverty is 25 times lower and extreme poverty is 50 times lower. And citizens in free countries live 25% longer than citizens in repressed countries.

Now, what do we mean when we talk about libertarianism?

And let me quote the words of the greatest authority on freedom in Argentina, Professor Alberto Benegas Lynch Jr, who says that libertarianism is the unrestricted respect for the life project of others based on the principle of non-aggression, in defense of the right to life, liberty, and property.

Its fundamental institutions are private property, markets free from state intervention, free competition, and the division of labor and social cooperation, in which success is achieved only by serving others with goods of better quality or at a better price.

In other words, successful capitalist entrepreneurs are social benefactors who, far from appropriating the wealth of others, contribute to the general well-being.

Ultimately, a successful entrepreneur is a hero.

And this is the model we are defending for the future of Argentina. A model based on the fundamental principle of libertarianism.

The defense of life, liberty, and property.



Now, if free enterprise capitalism and economic freedom have proven to be extraordinary instruments for ending world poverty, and we are now in the greatest moment in human history, it is worth asking why I say the West is in danger.

And I say this precisely because in countries that are supposed to defend the values of free markets, private property, and other institutions of libertarianism, sectors of the political and economic establishment are undermining the foundations of libertarianism, opening the doors to socialism and potentially condemning us to poverty, misery and stagnation.

It must never be forgotten that socialism is always and everywhere an impoverishing phenomenon that has failed in every country where it has been tried.

It was an economic, social, and cultural failure and also killed more than 100 million human beings.

The essential problem facing the West today is not just that we need to confront those who, even after the fall of the Berlin Wall and the overwhelming empirical evidence, continue to advocate impoverishing socialism.

But so are our leaders, thinkers, and academics who, relying on a misguided theoretical framework, are undermining the foundations of the system that has given us the greatest expansion of wealth and prosperity in our history.

The theoretical framework I am referring to is Neoclassical economic theory, which projects a set of instruments that, unintentionally or unintentionally, end up serving state intervention, socialism, and social degradation.

The problem with Neoclassicists is that the model they have fallen in love with doesn't map to reality, so they attribute their errors to supposed market failures rather than revising the model's assumptions.

Under the pretext of an alleged market failure, regulations are introduced. These regulations create distortions in the price system, impede economic calculation, and therefore also impede savings, investment, and growth.

The problem lies mainly in the fact that not even supposed libertarian economists understand what the market is because, if they did, they would quickly see that there can't be market failures.

The market is not a mere graph describing a supply and demand curve. The market is a mechanism of social cooperation, where you voluntarily exchange property rights. Therefore, based on this definition, talking about market failure is an oxymoron. There are no market failures.

If transactions are voluntary, the only context in which there can be market failure is if there is coercion and the only one capable of coercing is generally the state, which has a monopoly on violence.

Consequently, if anyone considers that there is a market failure, I suggest they check whether there is state intervention involved in free countries living 25% longer than citizens in repressed countries.

Consequently, if someone considers that there is a market failure, I suggest that they check whether state intervention is involved.

And if you find that this is not the case, I suggest you check again, because there is an error. Market failures do not exist.

An example of the so-called market failures described by Neoclassicists is the concentrated structure of the economy. From the year 1800, with the population multiplying by 8 or 9 times, GDP per capita grew more than 15 times, so there were increasing returns that reduced extreme poverty from 95% to 5%.

However, the presence of increasing returns involves concentrated structures, what we would call a monopoly. So, how is something that generated so much well-being for Neoclassical theory a market failure?

Neoclassical economists think outside the box.

When the model fails, we should not get angry with reality, but with the model and change it. The dilemma faced by the Neoclassical model is that they say they want to improve the function of the market by attacking what they consider to be flaws.

But in doing so, they not only open the door to socialism but also go against economic growth.

For example, regulating monopolies, destroying their profits, and destroying increasing returns would automatically destroy economic growth.

However, faced with the theoretical demonstration that state intervention is harmful – and the empirical evidence that it could not have been otherwise – the solution proposed by collectivists is not greater freedom, but rather greater regulation, which creates a downward spiral of regulations. until we are all poorer and our lives depend on a bureaucrat sitting in a fancy office.

Faced with the resounding failure of collectivist models and the undeniable advances in the free world, socialists were forced to change their agenda: they left behind the class struggle based on the economic system and replaced it with other supposed social conflicts, equally harmful to life and society. economic growth.

The first of these new battles was the ridiculous and unnatural struggle between men and women. Libertarianism already provides for equality between the sexes. The cornerstone of our belief is that all human beings are created equal and that everyone has the same inalienable rights granted by the Creator, including life, liberty, and property.

All the radical feminist agenda led to was greater state intervention to hamper the economic process, giving jobs to bureaucrats who contributed nothing to society. Examples are women's ministries or international organizations dedicated to promoting this agenda. Another conflict presented by socialists is that of human beings against nature, claiming that we, human beings, have damaged a planet that must be protected at all costs, going so far as to defend population control mechanisms or the abortion agenda. Unfortunately, these harmful ideas have gained traction in our society.

Neo-Marxists managed to co-opt the common sense of the Western world, and this they achieved by appropriating the media, culture, universities, and also international organizations.

The last case is probably the most serious, as these are institutions that have enormous influence on the political and economic decisions of their member states.

Fortunately, there are more and more of us who dare to make our voices heard, as we see that if we do not truly and decisively fight against these ideas, the only possible fate is that we will have increasing levels of state regulation, socialism, poverty and less freedom, and, therefore, worse living standards.

The West, unfortunately, has already started to follow this path. I know, to many, it may seem ridiculous to suggest that the West has turned to socialism, but that is only ridiculous if you stick to the traditional economic definition of socialism, which says it is an economic system where the state owns the means of production.

This definition, in my opinion, should be updated in light of current circumstances.

Today, states do not need to directly control the means of production to control all aspects of individuals' lives.

With tools such as money printing, debt, subsidies, interest rate controls, price controls, and regulations to correct supposed market failures, they can control the lives and destinies of millions of individuals.

This is how we have reached the point where, using different names or disguises, a good part of the ideologies generally accepted in most Western countries are collectivist variants, be they openly communist, fascist, socialist, social democrat, national socialist, democrat-Christians, neo-Keynesians, progressives, populists, nationalists or globalists.

In the end, there are no big differences. They all say that the state should direct all aspects of individuals' lives. Everyone defends a model contrary to the one that led humanity to the most spectacular progress in its history.

We come here today to invite the Western world to return to the path of prosperity. Economic freedom, limited government, and unlimited respect for private property are essential elements for economic growth.

The impoverishment produced by collectivism is not a fantasy, nor is it an inescapable destiny. It is a reality that we Argentines know very well.

We live it. We went through this because, as I said earlier since we decided to abandon the model of freedom that made us rich, we have been caught in a downward spiral - a spiral whereby we are becoming poorer and poorer, day by day.

This is something we have experienced and we are here to warn about what could happen if countries in the Western world, which became rich through the model of freedom, remain on this path of servitude.

The case of Argentina is an empirical demonstration that, no matter how rich you may be, how much natural wealth you may have, how qualified your population is, how educated, or how many gold bars you may have in the central bank - if measures are adopted that hinder the free functioning of markets, competition, price systems, trade, and private property, the only possible destination is poverty.

Therefore, in conclusion, I would like to leave a message for all the entrepreneurs present here and those who are not here in person, but who are following from all over the world.

Do not be intimidated by the political caste or the parasites who live at the expense of the state. Do not surrender to a political class that only wants to remain in power and maintain its privileges. You are social benefactors. You are heroes. You are the creators of the most extraordinary period of prosperity we have ever seen.

Don't let anyone tell you that your ambition is immoral. If you make money, it is because you offer a better product at a better price, thus contributing to general well-being.

Do not surrender to the advancement of the state. The state is not the solution. The state is the problem itself. You are the true protagonists of this story and rest assured that from today onwards, Argentina is your firm and unconditional ally.

IS THERE A CLIMATE CRISIS?

"Climate crisis" is an expression that has been used to highlight the environmental situation of the planet about climate change, but is there a real crisis, or does it generate the right crisis for political decision-making? As the planet and climate are something that covers the entire world, it would be a global crisis, right? Kyoto Agreement, Paris Treaty, and COP, among many "agreements" to cooperate on the climate issue and no one proves that global warming happens.

In 2023, physicist John Clauser, who won the Nobel Peace Prize, left scientific society with its hair standing on end when he said: "there is no climate crisis"!

"There was an overwhelming consensus that what I was doing was useless" in the 1970s, he said in an interview after the news conference. "It took 50 years for my work to win the award. That's how long it takes for opinions to change."

"As much as this may upset many people, my message is that the planet is not in danger," Clauser told an audience of about a dozen people in the hotel conference room and others watching online. "I consider myself a climate denier," he added. "I was told this is not politically correct. So I guess I'm a climate crisis person."

Ricardo Augusto Felício is a Brazilian geography professor, meteorologist, and politician. He was a professor and researcher in the Department of Geography at the Faculty of Philosophy, Letters, and Human Sciences at the University of São Paulo.

Ricardo's speeches gained prominence for contesting global warming.

"The sea level remains in the same place. Firstly, if it were to melt something, it would have to be Antarctica, but to melt it you have to have a temperature on Earth that is twenty or thirty degrees higher", explained the professor who is an Antarctic climate expert.

Ricardo also stated that the greenhouse effect is impossible physics and that the ozone layer is something that does not exist. The professor also answered questions from the audience such as whether the Amazon is the lungs of the world and whether the characteristic drizzle of São Paulo is decreasing"

LUIZ CARLOS MOLIN

Luiz Carlos Molin, in 2023, a retired professor from Alagoas, came out strongly with his position in the CPI of NGOs: For him, the Amazon does not interfere decisively with the planet's climate.

"If the entire Amazon were to be deforested, the global climate would not be affected," he declared during the hearing. For him, the oceans - which absorb 94% of incoming solar radiation and constitute 71% of the planet's surface - are the great commanders of the global climate, not the Amazon. "If the entire Amazon were deforested, the global climate wouldn't even notice"

Luiz Carlos Molin has been working in the same vein as the famous Dr Ricardo Felício, in one of his lectures that they were together he said: "The objectives of those who talk about climate change are to freeze developing countries. Brazil is the main focus of these operations that involve the environment and climate. The idea of climate change and these environmental issues are to hold back our development",

Rircaro Felício continues to defend and contest the thesis of global warming in the text he wrote for Oeste magazine, denying the IPCC

Professor Roger A. Pielke Jr., an American political scientist, clearly highlighted the paradoxical situations that the Intergovernmental Panel on Climate Change (IPCC) finds itself in with its models based on economic and energy guidelines (and never on a free Earth's atmosphere).

In the last one, the IPCC ended up contradicting its assessment made in a report when it released a short message on the Twitter platform. According to Pielke, in the latest report, the IPCC states that: **“(...) there is low confidence in human influence on changes in high river flows on a global scale. In general, there is low confidence in attributing changes in the probability or magnitude of flood events to human influence...”**, but in the platform message on July 25, the IPCC made the opposite statement, where they stated that **“Climate change induced by Man is already affecting many climates and weather extremes in all regions of the world with heat waves and fires, heavy rains and floods.”**

Pielke reports in his literature that you could randomly choose a person from the 1920s and you would find that they had a 0.01% probability of dying because of a dangerous weather event or an extreme regional climate condition somewhere in the world. world. Currently, the probability would be 0.00025%, that is, the risk has been reduced by around 99.75% and, as we have seen in previous articles, the greatest probability of people dying is due to very low temperatures, that is, it is the cold that kills much more.

This is the result of what you gain when you do not do Science, but propaganda, easily observable in the media and alarmist statements of the IPCC and its host of associates like all the pseudo-journalistic NGOs that infest the internet today, as it is easier to attack people than hide the truth of having to explain the complete lack of evidence for the statements proposed by the climate hypothesis, where man changes the Earth's climate

CO₂, IS IT REALLY A VILLAIN?

Israeli astrophysicist Nir Shaviv, from the University of Jerusalem: "There is no evidence on any time scale showing that CO₂ variations or other changes in the energy balance caused large temperature variations," says Shaviv. "There is, however, evidence to the contrary.

The tenfold variations in the amount of CO₂ over the last half a billion years have not correlated with temperature in controlling it.

A counterpoint, by former candidate Al Gore, in his 2001 film, *An Inconvenient Truth*, shows that the emission of CO₂ gases increases the earth's temperature. What he didn't mention is that the ice samples show that the increase in temperature precedes the increase in CO₂ levels, i.e. the opposite.

Not only Shavi, but Robert Giegengack, geologist and former chair of the Department of Earth and Environmental Science at the University of Pennsylvania, recognized this fact, saying that CO₂ does not cause temperature increases, instead "temperature regulates CO₂." (2018)

Felício claims that Shaviv's statements are based on real evidence. One important fact that corroborates this comes from geology. American geologist Ian Clarke is a renowned paleoclimatologist who works with Arctic samples and rock strata. He also belongs to the group of skeptics. His analyses point to the Earth's record temperature over tens of millions of years. He and other geologists and glaciologists have long since discovered a link between carbon dioxide and temperature. (west magazine)

WHAT IS THE IMPORTANCE OF CO₂?

The six elements that are fundamental to life, because without them life would not exist, are the famous CHONSP, Carbon, Hydrogen, Oxygen, Nitrogen, Sulfur, and Phosphorus. Imagine when the media discovers that in addition to the letters C and O, there are four more to create a new green apocalypse. In addition to these atoms, we have sunlight and heat, without which there would be no photosynthesis.

Carbon is the platform for life mainly as a great fertilizer, and based on a bibliography by Dr. Ricardo Felício, Richard Jakubasko, and Odo Primavezi, they also agree on:

The GHG greenhouse gas layer: is made up of 99% nitrogen and oxygen, with only the remaining 1% containing carbon, hydrogen, methane, and other chemical compounds.

Of this 1%, carbon represents 0.035% today, an increase of 20% over 200 years, the beginning of the industrial era.

Both also agree that even the margin between 278 and 380 ppm (parts per million) is not enough to prophesy a global cataclysm.

Felicio in his article in Oeste magazine states that “.. CO₂ rates are still very small and if they increased, the values remained in the thousandths range. If this occurred, it was probably very beneficial for the plants. Some scientific work that used a series of satellite images since the 1980s demonstrated that the planet has become greener, both through natural and planted vegetation (agriculture and forests). It seems that forests would then be a great sink for carbon from the atmosphere, absorbing it.

However, things are not that simple. Firstly, because stabilized forests consume carbon only to maintain their life cycles, contributing little to storage. Therefore, this exacerbated consumption would only occur during plant growth and, in medium and high-latitude forests, in the spring, when foliage is restored. Therefore, we conclude that CO₂ is a great natural fertilizer, with properties to accelerate and, possibly, even expand plant growth.

According to Dr. Richard Jakubaszko, in addition to photosynthesis, he mentions that around 60% of the carbon in the atmosphere is sequestered by seaweed and 40% by remaining urban forests and trees, other natural vegetation, and agricultural activities and 50% of carbon is fixed in trees (wood, trunks, and roots) and agriculture (in roots) in the form of “stored carbon”.

Not only Richard but also Luiz Carlos Molin: Co₂ is not a toxic or poisonous gas, it is life. Plants photosynthesize with CO₂ and, with concentrations below 200ppmv (parts per million and volume), most plants are unable to photosynthesize and die, and with them humans and animals. Therefore, the higher the concentration of Co₂, the greater the benefit for the Earth and its inhabitants.

“...the concentration of CO₂ in the atmosphere does not control the global climate. The atmosphere does not “create” energy to heat the planet, it only slows down the loss of thermal IR (infrared radiation), emitted by the surface, into outer space. Reducing human CO₂ emissions would be useless as it would not affect the climate.

It is observed that there is no unanimity of scientists, meteorologists, and physicists who agree on the climate crisis. An important factor to consider is that only 1/3 of the planet is terrestrial, and 40% of this land is desert, semi-arid, degraded places. Is this 1/3 capable of causing all this climate change?

We can agree with Pielke that the cold is what kills the most and this year in the United States it broke a record and reached -41°C . Minimum was recorded at Dillon Airport in Montana, at least 40 people died in the storms. Finally, some phrases, from the Skeptics' Manual, from some who believed in global warming and by studying reality changed their view, read carefully.

Astrophysicist Dr. Nir Shaviv, one of Israel's youngest prize-winning scientists, "believes that there will be more scientists converting to anthropogenic global warming skepticism when they discover the paucity of evidence."

Geologist Bruno Wiskel from the University of Alberta once presented how to build a "Kyoto-style house" in honor of the Kyoto Protocol, however, he recently wrote the book "The Empire of the New Climate: exposing global warming to ridicule".

Ivar Giaever, winner of the Nobel Prize in Physics, says "I am a skeptic... Global warming has become a new religion".

Dr. Kiminori Itoh, a PhD winner in physical environmental chemistry, says the warming scare is the "worst scientific scandal in history... When people find out what the truth is, they will feel let down by science and scientists."

Andrei Kapista, a Russian geographer and Antarctic ice sheet researcher, says "Kyoto theorists put the cart before the horse. This global warming is what marks high levels of carbon dioxide in the atmosphere, not the other way around...".

Botanist Dr. David Bellamy, a famous British environmentalist trailblazer, professor at Durham University, and presenter of a popular British wildlife TV series, said "Global warming is largely a natural phenomenon. The world is spending a stupendous amount of money trying to fix something that cannot be fixed."

Atmospheric physicist James A. Peden notes, "Many [scientists] are now looking for a discreet way to get out [of promoting warming fears] without ruining their careers."

IS THE AGE OF COAL AND OIL OVER?

The history of fuel dates back to the beginnings of humanity. The first fuels used by man were wood and animals, which were burned to provide heat and light.

From the 13th century onwards, coal began to be used as fuel in furnaces and steelworks. Coal was more efficient than wood and could be mined in large quantities, making it an important energy source during the Industrial Revolution.

In the 19th century, oil was discovered in the United States. Oil was a more efficient source of energy than coal and could be transported more easily. Oil quickly became an important energy source for transportation, industry, and electricity generation.

According to Daniel Yergin, "The cry that echoed in August 1859 across the narrow valleys of western Pennsylvania – that the crazy Yankee, 'Colonel' Drake, had struck oil – started an immense oil rush, which never again occurred. has since ended. From then on, in war and peace, oil would gain the power to build or destroy nations and would be decisive in the great political and economic battles of the 20th century. But again and again, during the endless adventure, the great ironies of oil became apparent. Your power has a price.

For almost a century and a half, oil has revealed the best and worst of our civilization. It has become a privilege and a burden.

Energy is the basis of industrial society. Of all energy sources, oil has proven to be the most important and the most problematic, due to its central role, its strategic nature, the recurrent supply crises, and the inevitable and irresistible temptation to seize its resources.

Here human figures appeared, both noble and ignoble. Creativity, dedication, entrepreneurship, ingenuity, and technological innovation coexist with greed, corruption, blind political ambition, and brute force.

Oil allows you to control the physical world. Our daily life and our daily bread are provided by agricultural chemicals and transportation. It also intensifies the global struggle for political and economic supremacy.

The fierce and often violent quest for oil – and the riches and power inherent in it – will surely continue as long as he occupies this central position. For ours is a century in which every facet of our civilization has been transformed by the modern and mesmerizing alchemy of oil. That's what made the oil age."

Churchill, on the eve of World War I, grasped a fundamental truth. There was debate about the advisability of adapting the British Navy to use oil as an energy source instead of coal, the traditional fuel. With this replacement, it would have to depend on the distant and unstable supply of oil from Persia, as Iran was then called. However, the strategic benefits led the then First Lord of the Admiralty to decide that England would have to base its "naval supremacy in oil, "even if I had to face a sea of problems". Throughout the 20th century, oil meant hegemony. The search for hegemony is the subject of the book *Oil – A World History of Conquests, Power and Money*, written by Daniel Yergin (São Paulo, Paz e Terra, 2010).

"The proliferation of automobiles in the early 20th century increased global demand for high-performance fuels. In this way, fossil fuels (then used only to obtain oil) became the source of gasoline. the main source of gasoline." Fuel was widely used after World War II.

In the 1940s, advances in physics allowed nuclear energy to be explored for its potential in energy production. Despite the attractiveness of this argument, the construction of nuclear power plants has attracted a lot of attention from political and environmental authorities. Maintenance of this electrical equipment requires close supervision and any accident can have serious consequences.





During the 1970s, two oil crises led to the search for new sources of energy, mainly in Brazil. Due to the fermentation of sugarcane, anhydrous alcohol began to be used in vehicles, which could reduce the emission of polluting gases. Obtaining sugar cane from sugar until the 80s, the demand for this fuel currently on the rise, with the development of dual-fuel vehicles, its position in the international market has taken on a new boost. In recent decades, concern about the environmental impact of polluting gas emissions marked an unprecedented stage in the history of fuels. The construction of hydroelectric plants, solar panels, and wind energy have become sources of clean energy. Although production costs are high, these alternative resources can respond to more pressing problems as they arise.

In the 20th century, natural gas was also discovered and began to be used as an energy source. Natural gas is a clean and efficient energy source and has been used increasingly in recent years.

At the end of the 20th century, oil continued to be essential to security, prosperity, and the very nature of civilization.

Although the modern history of oil began in the second half of the 19th century, it was only in the 20th century that a complete transformation occurred. Three major themes underlie this story.

The first is the rise and development of capitalism and modern business. Worldwide, oil is the largest and most widespread business, completely defining the meaning of risk and reward. Since the last decades of the 19th century, Standard Oil has completely dominated the North American oil industry, occupying one of the first places among the largest multinational companies. Among the top ten of the five hundred companies listed by Fortune magazine in 2008, six were oil companies. Until an alternative source of energy is found, oil will continue to have far-reaching effects on the global economy; an increase in its price can stimulate economic growth or, on the contrary, trigger a recession. It is a massive generator of wealth, as "oil is quasi-money".

The second theme is that of oil as a product intimately intertwined with national strategies global power and politics. It was the driving force behind the main conflicts of the 20th century, from the two World Wars to the Cold War, when the battle for its control, fought between international companies and developed countries, was an important part of the struggle for decolonization waged by emerging nationalism.

Oil has also demonstrated that it can be "fool's gold". Oil wealth ended up destroying the Shah of Iran. Oil promoted Mexico's economy and then undermined it. The Soviet Union – the second largest exporter in the world – wasted the resources obtained with a military buildup that undermined the possibility of offering better living conditions for its people. The United States, once the world's largest producer and still the largest consumer, has to import between 55% and 60% of the oil supply it needs.

With the end of the Cold War, a new world order begins to take shape. Economic competition, regional struggles, and ethnic rivalries can replace ideology as the focus of international – and national – conflict, instigated by the proliferation of the armaments industry. A new type of ideology – religious extremism and jihad – has come to the fore. With all this, oil will continue to be the strategic product.

A third theme in the history of petroleum shows how our society has become a "Hydrocarbon Society". Initially, the oil business provided the "kerosene" that allowed the working day to be extended. At the end of the 19th century, John D. Rockefeller became the richest man in the United States thanks to the sale of kerosene. At that time, gasoline was just a useless byproduct before the advent of the automobile industry. When the invention of the incandescent light bulb seemed to indicate the obsolescence of the petroleum industry, a new era began with the development of the internal combustion engine powered by gasoline.

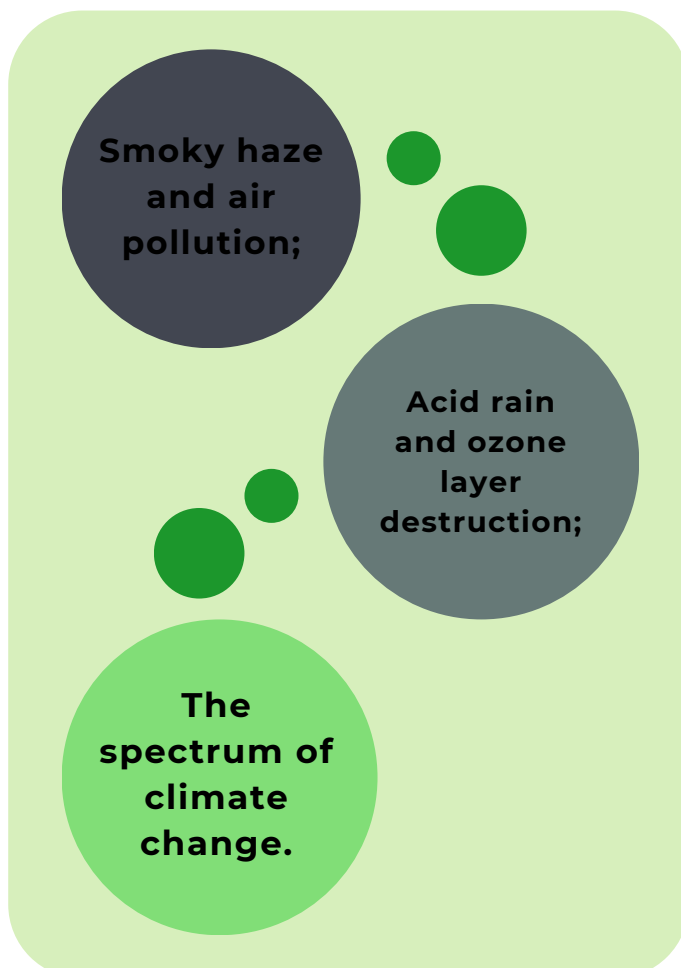
In the 20th century, natural gas, fueled by petroleum, replaced Royal Coal as the energy source in the industrialized world. Oil was the basis of the great post-war suburban movement. It's the soul of the suburbs. Like natural gas, it is an essential element in agricultural fertilization. Food can be delivered to major cities around the world that are not at all self-sufficient. They also supply the plastics and chemicals that make up the bricks and mortar of modern civilization.

In the 21st century, growing dependent on oil is no longer considered an advantage. With the growth of the ecological movement, the basic principles of industrial society, supported by the oil industry, are being challenged. Efforts are increasing to reduce the burning of all fossil fuels – oil, coal, and natural gas – due to their consequences:

Oil is now accused of contributing to environmental degradation and the oil industry is accused of posing a threat to current and future generations. This makes it necessary to implement technological innovations to reduce environmental challenges.

But the "Hydrocarbon Man" showed no desire to abandon his car and house located on the outskirts of the city. Any idea to reduce oil consumption will be influenced by the consumption of people in underdeveloped countries who now want the "right" to enjoy the benefits of durable consumer goods. For example, between 1990 and 2008, India's oil demand doubled, and China's oil demand more than tripled.

For this reason, there is a growing interest in alternative energy sources such as solar energy, wind energy, and nuclear energy. These energy sources are cleaner and more sustainable than fossil fuels, but they are still relatively expensive and not available on a sufficient scale to meet global energy demand.

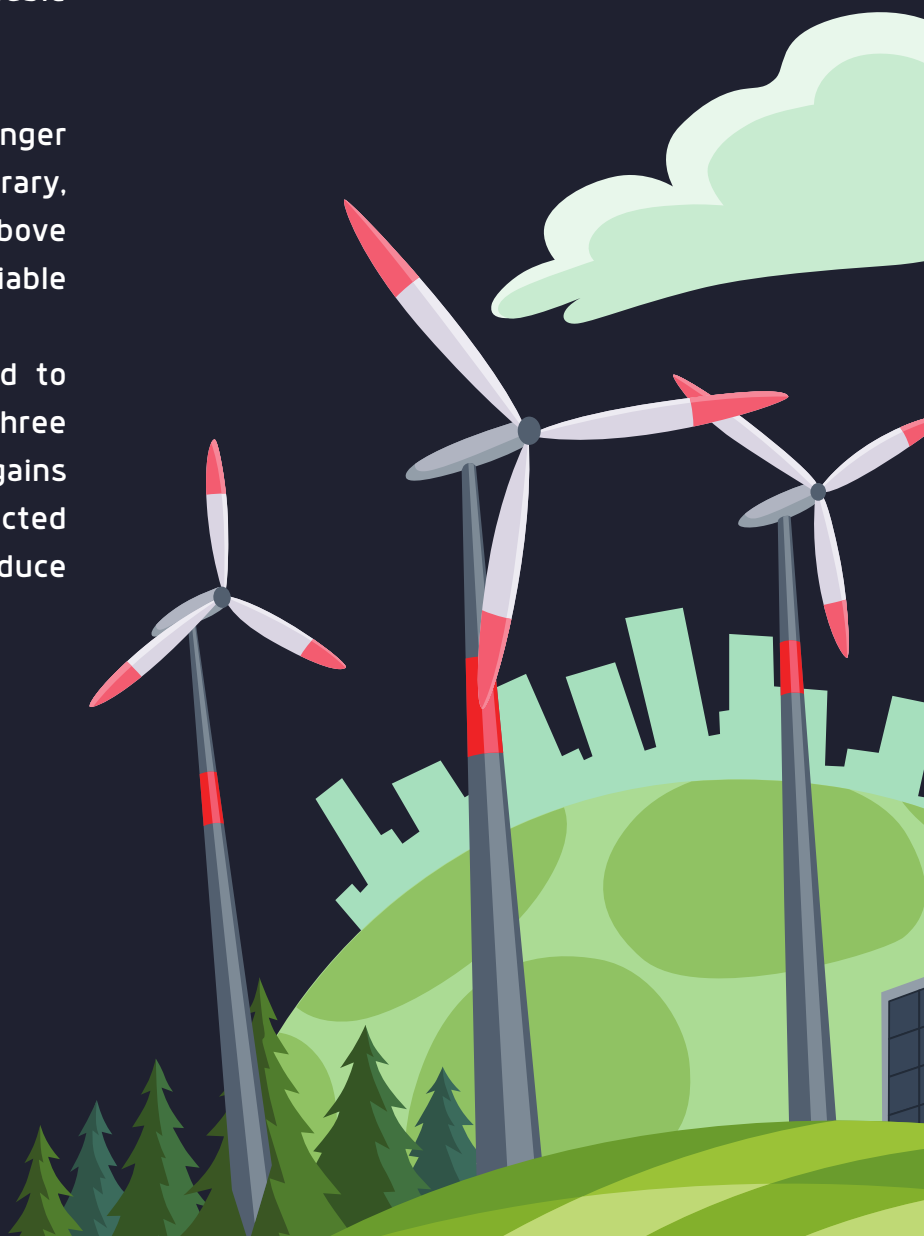
Renewable energies, the new era?

Renewable energy sources such as solar, wind, and hydroelectric power are becoming increasingly important. This change is being driven by several factors, including growing environmental problems caused by pollution and the development of new technologies that make renewable sources more efficient and affordable.

These renewable energies are no longer just an attractive idea; on the contrary, they are now an efficient, safe, and, above all, clean source of energy, a viable alternative to the use of fossil fuels.

Global electricity demand is expected to grow at a faster rate over the next three years as the clean energy transition gains speed, with all additional demand expected to be covered by technologies that produce low-emissions electricity.

Electricity 2024 is the latest edition of the IEA's annual analysis of electricity market developments and policies, providing forecasts for the sector's demand, supply, and carbon dioxide (CO₂) emissions until 2026. The report concludes that, although global electricity demand growth slowed slightly to 2.2% in 2023 due to falling electricity consumption in advanced economies, it is projected to accelerate to an average of 3.4% from 2024 to 2026. About 85% of the increase in global electricity demand by 2026 is expected to come from outside advanced economies - mainly China, India, and countries in Southeast Asia. However, record electricity generation from low-emissions sources - including renewables such as solar, wind, and hydro, as well as nuclear power - is expected to reduce the role of fossil fuels in providing energy to homes and businesses. Low-emissions sources are expected to account for almost half of the world's electricity generation by 2026, up from just under 40% in 2023.

Renewable energies are expected to represent more than a third of total electricity generation by the beginning of 2025, overtaking coal. By 2025, nuclear power generation is also expected to reach a global record as France's production increases, several plants in Japan come back online and new reactors begin operating commercially in many markets, including in China, India, Korea, and Europe. When the share of fossil fuels in global generation falls below 60%, this will be the first time it has fallen below that threshold in IEA records dating back more than five decades.



"The power sector currently produces more CO2 emissions than any other in the world economy, so it is encouraging that the rapid growth of renewables and a steady expansion of nuclear power are together on track to meet all the increased demand for global electricity supply over the next three years," said IEA Executive Director Fatih Birol. "This is largely due to the huge momentum behind renewables, with increasingly cheap solar power leading the way, and support from the important comeback of nuclear power, whose generation is expected to reach an all-time high by 2025. Although further progress if necessary, and quickly, these are very promising trends."

The report concludes that increased electricity generation from renewable and nuclear sources appears to be pushing power sector emissions into a structural decline. Global emissions from electricity generation are expected to decline by 2.4% in 2024, followed by smaller declines in 2025 and 2026.

The decoupling between global electricity demand and emissions would be significant given the increasing electrification of the energy sector, with more consumers using technologies such as electric vehicles and heat pumps. Electricity represented 20% of final energy consumption in 2023, up from 18% in 2015, although meeting global climate targets will require electrification to advance significantly faster in the coming years.

Electricity prices were generally lower in 2023 than in 2022. However, price developments varied greatly between regions, affecting their economic competitiveness. Wholesale electricity prices in Europe fell by more than 50% on average in 2023, after reaching historic highs in 2022 following Russia's invasion of Ukraine. However, electricity prices in Europe last year were still more than double pre-Covid levels, while prices in the United States were around 15% higher than in 2019. Electricity demand in the European Union decreased for the second year in a row in 2023 and is not expected to return to levels seen before the global energy crisis until 2026 at the earliest.

Although electricity demand in Europe and the United States declined in 2023, many emerging and developing economies have recorded robust growth that is expected to continue through 2026 in response to increasing populations and industrialization. Over the forecast period, China is expected to account for the largest share of the global increase in electricity demand in terms of volume, even as its economic growth slows and becomes less dependent on heavy industry. Meanwhile, India is expected to see electricity demand rise the fastest among major economies, with added demand over the next three years predicted to be roughly equivalent to the UK's current electricity consumption.

As a region, Africa remains an outlier in electricity demand trends, according to the report's analysis. While per capita electricity use in India and Southeast Asia has increased rapidly, it has been effectively stagnant in Africa for more than three decades.

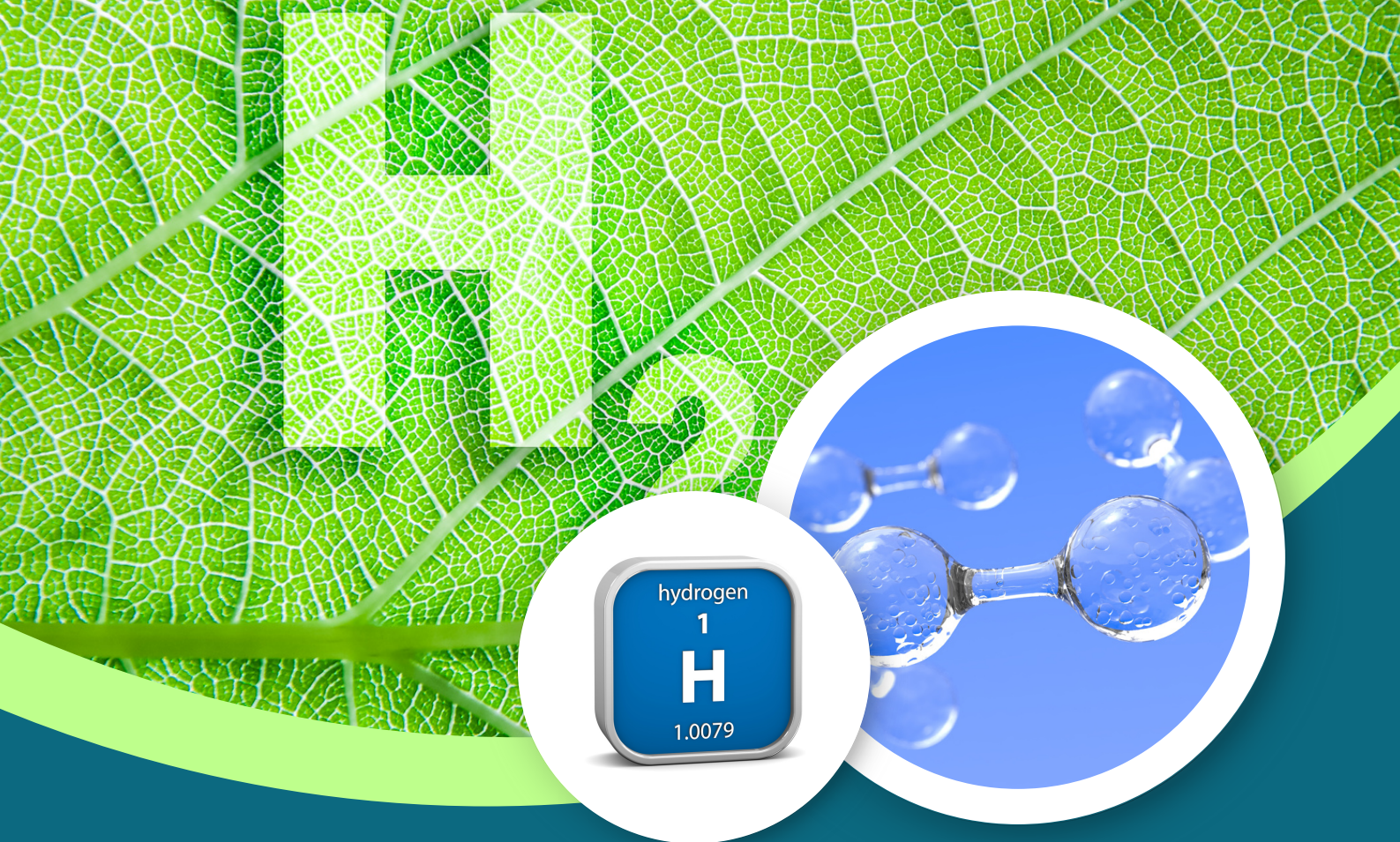
"Electricity use is a key indicator of economic development in any country, and it is a grim sign that it has stabilized in Africa on a per capita basis for more than three decades," Birol said. "Access to reliable, affordable, and sustainable energy for all citizens is essential for African countries to achieve their economic and climate goals. The international community needs to work together with African governments to enable the urgent progress that is needed."

GREEN HYDROGEN: THE FUEL OF THE FUTURE!

Green hydrogen (H₂V) is a type of hydrogen produced through the electrolysis of water, using electricity from renewable sources such as solar, wind, or hydropower. The electrolysis process separates the water molecule (H₂O) into its constituent elements, hydrogen (H₂) and oxygen (O₂).

Green hydrogen is considered a clean energy source as it does not emit greenhouse gases during its production. This makes it a promising alternative for the energy transition



HYDROGEN CLASSIFICATIONS ACCORDING TO PRIMARY ENERGY SOURCES (COLOR SCALE)

- Black hydrogen: produced by gasification of mineral coal (anthracite), without CCUS*.
- Gray hydrogen: produced by steam reforming of natural gas, without CCUS.
- Brown hydrogen: produced by gasification of mineral coal (coal), without CCUS.
- White hydrogen: produced by extraction of natural or geological hydrogen.
- Moss hydrogen: produced by catalytic reforming, gasification of waste plastics, or anaerobic digestion of biomass, with or without CCUS.

- Pink hydrogen: produced with a nuclear energy source.

GREEN HYDROGEN CHALLENGES

Even though it is expanding, one of the biggest challenges of using it on a large scale is the cost of producing it. High costs are associated with renewable energy production and electrolysis systems. However, with the growth of renewable energy, especially solar and wind energy, its future is promising.

 - Low carbon emissions;
 - Positive impact on air quality;
 - Versatility of use;
 - Generation and storage of electrical energy.

- Disadvantages of green hydrogen
 - High production costs;
 - Low efficiency;
 - Complex storage and handling (hydrogen is flammable).

- Green Hydrogen Applications
 - Among the applications are:
 - Used as fuel (sustainable transport);
 - Industrial sector (chemical industries, refineries, and steel mills).

Fuel of the future

How is green hydrogen used as a fuel? It can be used for this purpose in hydrogen fuel cell vehicles, capable of converting hydrogen and oxygen into electricity, generating only water as a byproduct.

Industry and green hydrogen

The chemical industry can use it to produce ammonia and methanol, important raw materials. Steel mills can replace coke coal through the direct reduction process. Furthermore, in refineries, it can be used in various stages of oil refining.

HAARP

HIGH FREQUENCY ACTIVE AURORAL RESEARCH PROGRAM

HAARP is a study project on the Earth's ionosphere that began in 1993, in Alaska (United States). HAARP, which stands for "High-Frequency Active Auroral Research Program", aims to better understand how radio wave transmissions work in the ionosphere (upper part of the atmosphere).

"The ionosphere extends 60 and 1000 km high, above the Earth's surface, right at the edge of space. Together with the neutral upper atmosphere, the ionosphere forms the boundary between Earth's lower atmosphere - where we live and breathe - and the vacuum of space. (NASA)

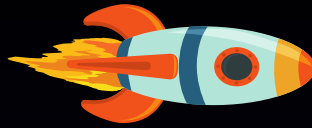
Between 1990 and 2014, HAARP was a program jointly managed by the United States Air Force (USAF) and the United States Navy. Its goal was to research the physical and electrical properties of Earth's ionosphere, which can affect our military and civilian communications and navigation systems. Operation of the research facility was transferred to the University of Alaska Fairbanks on August 11, 2015, allowing HAARP to continue the exploration of ionospheric phenomenology through a cooperative research and development agreement.

There are positively ionized particles and free electrons and it is primarily formed by the ionization of neutral gases, such as oxygen, nitrogen, and others, by solar radiation corresponding to certain wavelengths. Some wavelength ranges and specific lines in the sun's power flux spectrum are responsible for the formation of the ionosphere. Solar radiation periodically varies between maximum and minimum values and this variation affects the ionization rate of the ionosphere. In studies of the ionosphere, solar activity is characterized by the number of sunspots or the power flux density at wavelength.

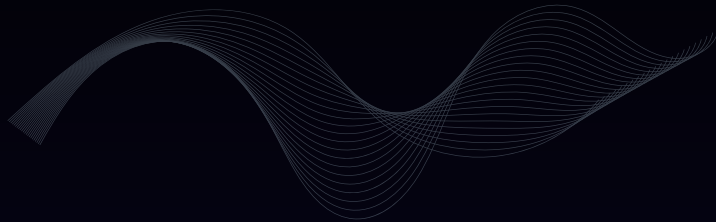

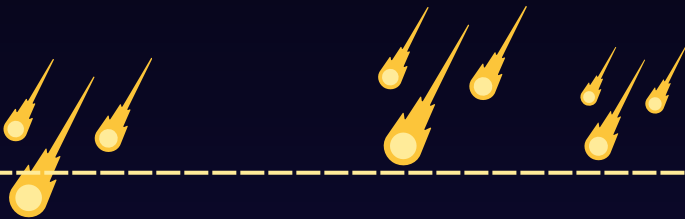

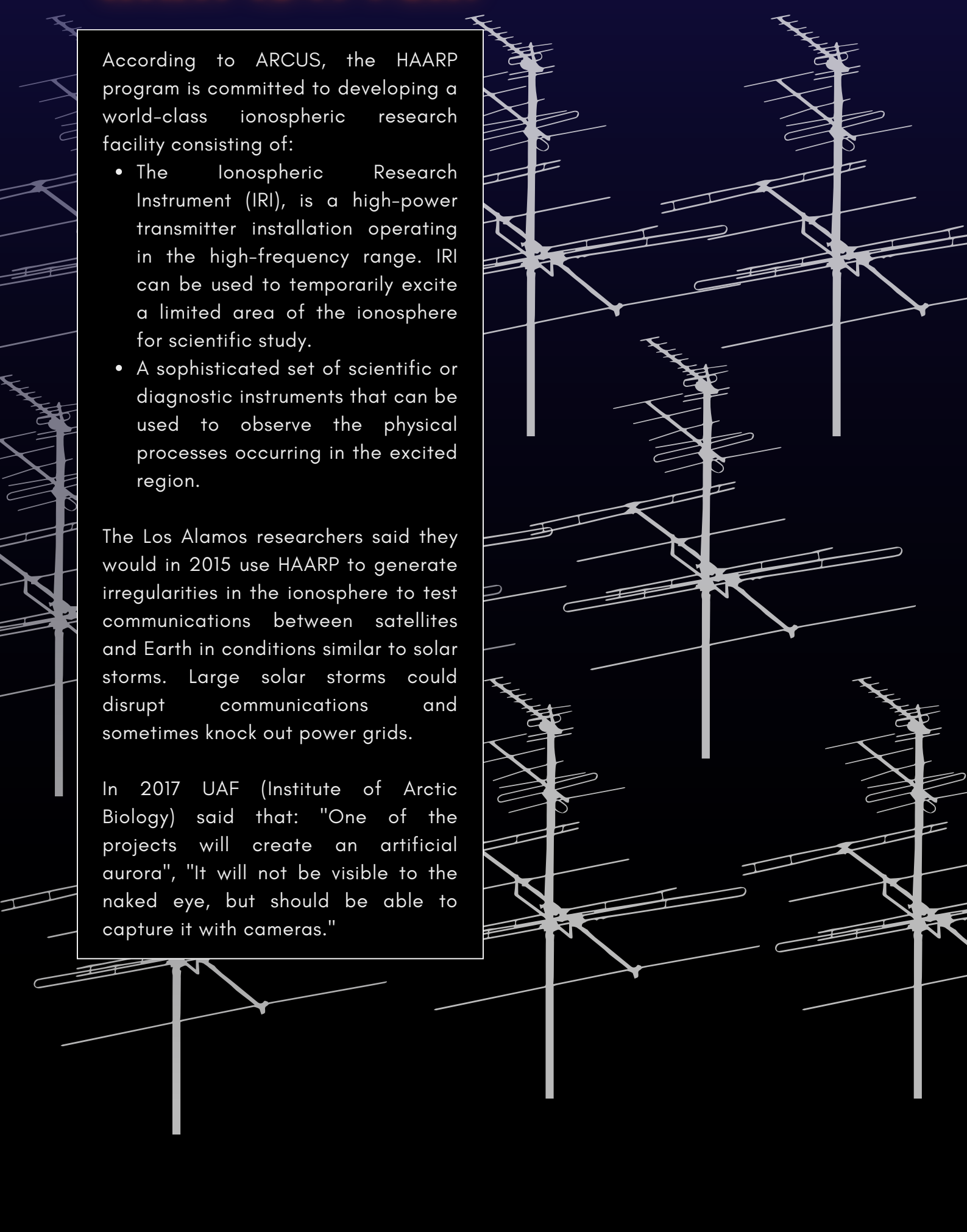
WHAT IS IT FOR?

According to ARCUS, the HAARP program is committed to developing a world-class ionospheric research facility consisting of:

- The Ionospheric Research Instrument (IRI), is a high-power transmitter installation operating in the high-frequency range. IRI can be used to temporarily excite a limited area of the ionosphere for scientific study.
- A sophisticated set of scientific or diagnostic instruments that can be used to observe the physical processes occurring in the excited region.

The Los Alamos researchers said they would in 2015 use HAARP to generate irregularities in the ionosphere to test communications between satellites and Earth in conditions similar to solar storms. Large solar storms could disrupt communications and sometimes knock out power grids.

In 2017 UAF (Institute of Arctic Biology) said that: "One of the projects will create an artificial aurora", "It will not be visible to the naked eye, but should be able to capture it with cameras."



EUROPEAN PARLIAMENT SAID THAT HAARP IS A WEAPON?

Brussels, 9 February 1998

"...Tom Spencer (PPE, United Kingdom), chairman of the Foreign Affairs Committee, said that the United States had been invited to present its point of view on this matter at the hearing. Although the US had declined an initial invitation, SPENCER reiterated his offer, saying that the Americans could send a representative to address the committee in the future if desired.

Rosalie BERTELL, from Toronto (Canada), is one of the experts on HAARP (High Frequency Active Auroral Research Programme), a program that was developed by the US military. She described the background to HAARP. The ionosphere is a high-altitude layer of the atmosphere with highly energetic charged particles. If radiation is projected into the ionosphere, enormous amounts of energy can be generated and used to annihilate a given region.

The HAARP project involves the manipulation of the Earth's ionosphere, whose natural role is to transfer moderate energy from the sun to the Earth and is used as a missile trajectory and as a reflector for radio communication. The purpose of HAARP is to control and manipulate the ionosphere in a way that allows the manipulator to eliminate communications at will on a global scale, or to make them resilient in the event of nuclear war.

It also allows communications to occur with submerged submarines and can, in theory, create geomagnetic pathways to guide beams of particles that could then deposit large amounts of energy anywhere on the globe. In simpler terms, HAARP, with its power to intimidate, supply or deny electrical power on a global scale, and its control of communications, is one element of a system that could control the global village in some frightening ways.

HAARP AND THE WEATHER?

Radio waves interact with electrical charges and currents, and do not interact significantly with the troposphere. Furthermore, if ionospheric storms caused by the sun don't affect the weather on [Earth's] surface, there is no chance that HAARP can do so. Electromagnetic interactions occur only in the near-vacuum of the rarefied, but still electrically charged, region of the atmosphere above 60 km to 80 km altitude [ionosphere]", explains the project website.

The prominent London newspaper "The Guardian" reported on the topic, for example (4.4.2012) in an article titled: "At war over geoengineering". ... At least four countries - the US, Russia, China, and Israel - possess the technology and organization to regularly alter climatic and geological events for various military and black operations [...] In effect, warfare now includes the technological ability to induce, enhance, or direct cyclonic events, earthquakes, drafts, and floods, including the use of polymerized aerosol viral agents and radioactive particles transported through global weather systems.

In 2010, the former president of Venezuela said that the earthquake in Haiti had been caused by American weapons. The newspaper "Vive" states that it had access to documents that prove the use of HAARP to manipulate Caribbean geophysics and cause the earthquakes in Haiti, which caused the deaths of more than 100,000 people. David Walker, Deputy Assistant Secretary of the Air Force for Science, Technology, and Engineering, 2014 dropped a bombshell in response to a question posed by Lisa Murkowski regarding the dismantling of the Auroral Research Program. \$300 million HAARP High-Frequency Activation at Gakona this summer.

Walker said this is "not an area we need for in the future" and that it would not be a good use of Air Force research funds to keep HAARP running. "We're moving toward other ways of managing the ionosphere, which is what HAARP was designed to do," he said. "Injecting energy into the ionosphere to be able to control it. But that work is done."

MIND CONTROL

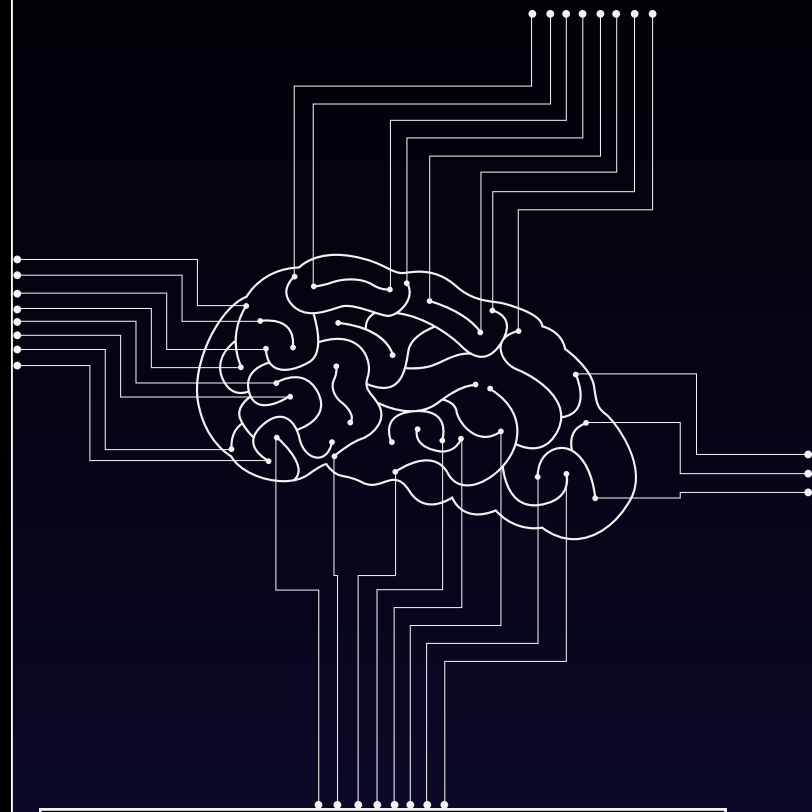
Finally, in 2017, the news channel VICE NEWS interviewed Dr. Nick Begich, doctorate in traditional medicine from the Open International University for Complementary Medicines, author of the book *Angels Don't Play This HAARP: Advances in Tesla Technology* (*Angels Don't Play This Harp, Advances in Tesla technology*) and also the book *Controlling the Human Mind: The Technologies of Political Control or Tools for Peak Performance* translated into 10 languages, and questioned whether Haarp could control minds.

WHAT IS THE SCHUMANN RESONANCE?

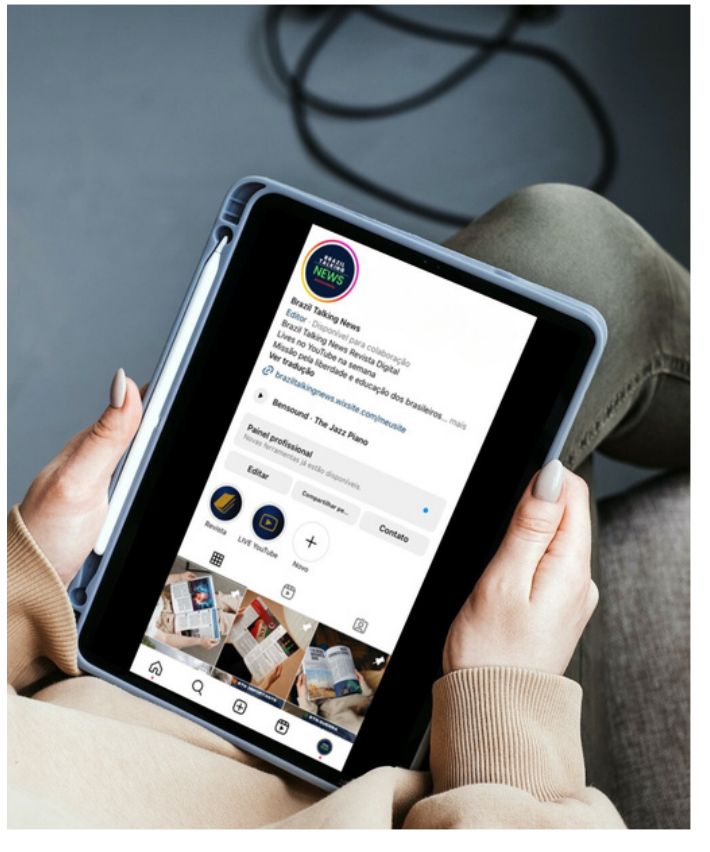

BRAZIL DOOMED? AND NOW?

One of the best stories I tell in the SUPERCONSCIÊNCIA BRASIL lecture, in a short video that is now on my YouTube channel, is that of a very old man walking with a lot of energy in the closed streets of a small town in Italy, at the very beginning of pandemic, when that country was apparently being devastated, and in full lockdown. He was storming through the deserted streets of that poor city, alone, speaking loudly and gesturing strongly, like a good Italian..., and someone filmed this remarkable scene, from the window of House.

This man said more or less like this: - "I had to leave the trenches, in the Second World War, with machine gun bullets grazing my head, I heard the sound of the bullets, I felt the wind of them in my face..., and now Do you want me to stay at home because of a virus?"

When I saw this Italian scene, I immediately remembered a story that my grandfather told about a Brazilian who, before leaving for Italy, shot himself in the foot, in an attempt to avoid going to war.

Today we are at war. Condemned to chaos. They say the dispute is between left and right thoughts. But, for me, it's just a war about (im)maturity, on very different sides, between good and evil.

We have two choices. Stay at home, run away, pretend to be dead, shoot yourself in the foot... or, leave the trenches, go for it, even with bullets passing by our heads. That is, shut up or face it.

But..., we cannot 'face it' anyway, we go with intelligence, a possible intelligence, thus increasing our chances of success. Reflection, strategy, love.

I doubt there is a Brazilian anywhere in the world who does not want to act and find a solution to what is now taking place. Information with intelligence is a weapon of war, but also a weapon of peace. You have to think. Together.

In another video in the same lecture as the first, I show the important part of a film, a short scene, but perhaps the strongest. A fiction, Captain America – Universal Soldier (if I'm not mistaken). At this point the director managed to lead the entire audience to believe that there is no more way out, evil has dominated and infiltrated everywhere, in all systems and institutions, and there is nothing more that can be done... (this reminds you of anything today?).

Captain America appears as if without any major pretensions, even when he arrives he says "Excuse me" and enters the place invaded by chaos. Recognizing something greater in others, regardless of the color of their shirt, or the mentality they have created throughout their life experience, know that most people are good. Whether they are red or green and yellow.

And it is this army that I seek with my lectures, texts, posts, books..., it is this same army that that Italian gentleman was waiting for, without even knowing it, while shouting through the streets of Italy; Jesus searched the Earth; and Captain America called in that movie – yes, fiction here, but what are we? Just narratives of a dream? Hope...? It is this army that God announces, almost shouting, every day.

HUNTING PIGS

In the Brazil of Santa Catarina, deputies, regularly, began to denounce that IBAMA, in August 2023, banned the hunting of wild boars, which would be posing a serious threat to farmers in the Southern States due to these animals' devastating plantations, attack the local fauna, without threatening the subsistence of the families of small farmers and cooperatives.

This whole story determined the rapid mobilization of deputies from that State aiming at the approval of PL 393/2023 which authorizes the hunting of these animals, overcoming the ineffectiveness and interests of the body which, within a governmental context of attack on agriculture, sat in on the subject perhaps hoping that the animals present some trans declaration in a way that would place them in the class of domestic animals.

Reading about this subject, my memory went back to 2020 when I had created a short video talking about exactly how the hunting of wild pigs (wild boars, peccaries, and peccaries) was carried out in a parallel with what is done to humanity from of continuous and imperceptible acts until it surrenders and when it realizes the trap, it is too late to react and it is all entangled within new, narrower structures.

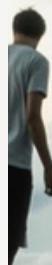
For a long time, researchers and doctors in religious knowledge spared no effort in the incessant search to answer their questions and those of millions of people around the world. What is God or what is God?

These changes can affect their mental health, leading to feelings of sadness, anguish, apathetic behaviors, isolation, and even some disorders such as anxiety and mood disorders - depression.

But as described above, this generation is more aware of the importance of mental health and is more likely to seek help when needed. This change is due to a series of factors, such as greater awareness of the importance of taking care of mental health; increased access to mental health services, and changes in the social roles of the elderly - more active and involved in society, helping them to better deal with the challenges of aging.

Despite positive changes, maintaining psychological health is still a challenge for many elderly people. Difficulties typical of age, loneliness, lack of care, and financial difficulties, can hinder the search for improvements, after all, to maintain psychological health, it is necessary to take better care of your physical health, stay active, and connect with other people, especially those they love.

This generation is breaking paradigms and changing the way the aging process is viewed. They are showing that it is possible to age with quality of life, by adopting healthy habits, seeking information regularly, and paying attention to mental health.

This change in mindset has impacted not only their own lives but also those of future generations. Today's elderly people are serving as an inspiration to younger generations, who are increasingly aware of the importance of taking care of their physical and mental health at all stages of life.
